

# Supplementary Regulations Bristol Pegasus Motor Club Brightside Autosolo & Production Car Autotest

Sunday 15th March 2019

Bristol Pegasus Motor Club are pleased to be able to run a fun Autosolo and Production Car Autotest at Severn Bridge OLD services with the kind permission of Brightside Group.

Note there will be two events running in parallel to give maximum flexibility:


- a Clubmans Autosolo: and
- a Clubmans Production Car Autotest.



The event will consist of a number of timed all-forward tests. The event takes place on smooth tarmac and should appeal to anyone who would like a bit of fun in their car. Any road car should be suitable. A Motorsport UK clubman RS competition licence is required which is free. We recommend applying for the licence before the day - <a href="https://www.motorsportuk.org/get-started/2020-rs-clubman-licence/">https://www.motorsportuk.org/get-started/2020-rs-clubman-licence/</a> Licence application forms will also be available on the day. Unfortunately we have had to increase the entry fee to £15 to cover the increase in permit fees charged to the club by Motorsport UK. It is still one of the lowest cost events of this type.

### **Supplementary Regulations**

- 1. The Bristol Pegasus Motor Club will organise a Clubmans status Autosolo and a Clubmans Production Car Autotest on Sunday 15th of March 2019 at Brightside Group, Brightside Park, Severn Bridge, Aust, Bristol, BS35 4BL.
- 2. The meeting will be governed by the General Regulations of the Motorsport UK (Incorporating the provisions of the International Sporting code of the FIA), these Supplementary Regulations, and any written instructions that the organising club may issue for the event.
- 3. The following Motorsport UK Permits have been issued; Clubmans Autosolo permit 117462 and Clubmans Production Car Autotest permit 117463.
- 4. The Event is open to all fully elected members of the Bristol Pegasus Motor Club and all fully elected members of the following clubs:

  Bristol Motor Club, the MGCC (South West Region), Bath MC, Weston Motor Club and Tavern Motor Club
- 5. All entrants in the event must produce a valid membership card for either the promoting club or the invited club. All Competitors must meet the minimum ages set out on the front page of this document. A Motorsport UK clubman RS competition licence is required which is free. We recommend applying for the licence before the day <a href="https://www.motorsportuk.org/get-started/2020-rs-clubman-licence/">https://www.motorsportuk.org/get-started/2020-rs-clubman-licence/</a> Licence application forms will also be available on the day.
- 6. The programme of the meeting will be as follows:

Signing on and Scrutineering starts at 10.00 hrs.

Any competitor not signed on by 10.30 hrs may be EXCLUDED.

The first car will start at 10.45 hrs.

#### 7. Route

Public roads will not be used to link sections.

The route to be followed on each course will be designated using cones supplemented by yellow cones laid on their side to show which side to pass each marker. Numbered boards will show the order in which each marker is to be passed. Start and finish will be marked on each course. Timing will start when the front wheels cross the start line. Competitors must "stop astride the finish line, timing will stop when the front wheels cross the finish line. Competitors must return to the paddock at walking speed.

A Stop Signal will be displayed if there is an obstruction on the course. A competitor must stop immediately on deployment of the signal and re-run allowed. The Stop Signal will be shown at the drivers briefing.

## 8. Classes & Vehicles

All vehicles entering the Autosolo must be driven into the venue.

Autosolo - tax and MOT required

Production Autotest - tax and MOT not required.

Entries of vehicles with four wheel drive will be accepted. Commercial type vehicles may compete. All vehicles must comply with Motorsport UK Technical Regulations, including being fitted with an effective silencer.



The AutoSolo and the PCA will each consist of four classes as follows:

- A. Series Production Cars Saloon cars up to 1400cc
- B. Series Production Cars Saloon cars 1401cc to 2000cc
- C. Series Production Cars Saloon cars over 2000cc in class
- D. Series Production Sports Cars
- E. Specialist Production Cars, including Lotus Elise, VX220, kit cars and all other vehicles not eligible in for classes A, B, C and D.

A petrol engine car with forced induction, in Class A, or B will move up one capacity class. A rotary engine's capacity will be increased by a multiple of 1.5. Vehicles must compete on road legal tyres that are NOT on Motorsport UK's List 1B and 1C (see separate page for details).

Sports or open cars running in the AutoSolo may compete with hood down.

Sports or open cars running in the PCA may compete with hood down provided passenger is 16 years of age or older.

9. Awards will be presented as follows:

1<sup>st</sup> in class An award

2<sup>nd</sup> in class

An award (subject to 5 or more entries in the class)

3<sup>rd</sup> in class

An award (subject to 9 or more entries in the class)

10. The entry list opens on publication of these regulations and closes on the 15th March at 10.30 hrs. The entry fee is £15.

Paper entries must be made on the official entry form and accompanied by the appropriate fee. Cheques should be made payable to Bristol Pegasus Motor Club.


- 11. The secretary of the meeting, to whom all entries should be sent, is: Philip Turner
- 12. The maximum entry for the meeting, including reserves, is 25. The minimum is 5. Should the above minimum figure not be reached, the organisers have the right to cancel the meeting. Entries will be selected at the discretion of the organisers. Entry fees may be refunded if the entry is withdrawn and notice given in writing to the secretary of the meeting, at least 24 hours before the event is due to start.

13. Other officials are:

Clerk of the Course: Nick Wood

Scrutineer: TBC Club Steward: TBC Results: Bob Bull

All officials, and competitors while acting as marshals, will be Judges of Fact to adjudicate on false starts, hitting cones and not following correct route. Their determination is not subject to appeal or protest (G.10.1.1).



#### 14. Tests and Penalties

There will be at least two runs on each course.

Competitors will be required to walk each course before attempting each test.

PCA drivers must have the same passenger throughout the event.

Results will be determined by discarding the worst time recorded on each course.

Timing will be by hand-held stopwatch to the tenth of a second.

Where there is a tie, the result will be determined by the aggregate of the first runs over each course.

Scorecards, which will be the only record of your performance, will be issued

Your times for each test will only count if you have marshalled when required to do so.

Penalties will be determined as follows:

Striking a marker cone – 5 Seconds

Failure to stop astride the finish line – 5 Seconds

Not attempting or not being ready to attempt a test when called - Maximum Penalty

Taking an incorrect route - Maximum Penalty

Note: if the competitor returns to the point of departure from the correct route and complete the course correctly there shall be no penalty.

Completing the course in a time that exceeds the Penalty Time - Maximum Penalty

Maximum Penalty is the fastest recorded time in the class on that course + 30 seconds

- 15. Provisional results will be published by despatching a copy by email or on request by post within 7 days of the event. Any protest must be lodged in accordance with section C 5.
- 16. Competitors will be identified by numbers which will be provided by the organisers.
- 17. All other General Regulations of Motorsport UK apply as written.
- 18. Awards will be available for collection at the Pegasus Annual General Meeting. If unable to attend the competitor is to make arrangements for award collection.
- 19. In line with Motor Sports Association policy, the Bristol Pegasus Motor Club has a responsibility to safeguard and promote the wellbeing of young people working and competing in motor sport. 

#### Indemnification

#### I declare that:

- 1. I have been given an opportunity to read the General Regulations of the Motor Sports Association and, if any, the Supplementary Regulations for this event and agree to be bound by them.
