

Introduction

The event will consist of normal trials sections. The event should appeal to anyone who has previously entered our Trials or those new to Trials and any road car should be suitable.

This event is a round of the 2024 ASWMC Car Trials Championship, AWMMC Cars Trials Championship and the Cotswold Motor Sport Group Car Trial Championship.

Drivers and passengers now require a Motorsport UK clubman RS competition licence which is free. We recommend applying for the licence before the day.

Race with Respect - Encouraging a positive environment, on and off the track.

A socially minded standard of behaviour is expected from everyone within the motorsport community. By participating in a Motorsport UK event, in any capacity, you are agreeing to follow the values of the governing body's Respect Code: Respect; Integrity; Fair play; Self-control; Good manners. Supplementary Regulations

- 1. The Bristol Pegasus Motor Club will organise a Clubmans status Car Trial on the 28th April 2024 at Lower Grove Farm, Highridge Road, Dundry, Near Bristol. Map Reference 554½ 673½ Post Code BS41 8JT
- 2. The meeting will be governed by the General Regulations of Motorsport UK (incorporating the provisions of the International Sporting code of the FIA), these Supplementary Regulations, and any written instructions that the organising club may issue for the event.
- 3. The Motorsport UK Permit No. TBA has been issued.

4. The event is open to all fully elected members of the Bristol Pegasus Motor Club, and all fully elected members of the following clubs:

The Bristol Motor Club,
The Classic and Historic Motor Club,
The Cotswold Motorsport Group Competitors Club,
MGCC (South West Region)
plus registered contenders in the ASWMC Car Trials Championship 2024, AWMMC Car Trial
Championship 2024 and the CMSGCC Car Trial Championship promoted on behalf of the AWMMC.

5. Drivers and passengers now require a Motorsport UK clubman RS competition licence which is free. You should apply for the licence before the day - https://rsclubman.motorsportuk.org/

Scrutineering will be completed on the day and competitors Valid Competition Licence and Club Membership Cards will be inspected at signing on. Drivers under 18 must have parental/guardianship permission to take part.

Signing on will be completed on the day of the event.

- 6. The programme of the meeting will be as follows: Signing on and Scrutineering starts at 12-00. Any competitor not signed on by 12-45 may be EXCLUDED. The first car will start at 13-00.
- 7. Public roads will not be used to link sections. There will be at least 6 tests on private land, weather permitting. Each competitor will have at least two attempts at each test. Details of the tests will be issued at signing on. The entry may be split into groups starting on different sections.
- 8. The event will consist of five classes as follows:
 - 1 Front engine, front wheel drive production cars without additional ballast. A sump guard weighing no more than 10 kg, including fittings, may be fitted.
 - 2 Front engine, front wheel drive production cars with ballast.
 - 3 Front engine, rear wheel drive production saloons and production sports cars.
 - 4 Rear engine rear wheel drive production cars.
 - 5 Kit cars
 - 6 Specials

The organisers may add additional classes or merge classes in line with the entries received.

Entries of vehicles with four wheel drive will not be accepted. All vehicles must comply with Motorsport UK Technical Regulations, and must be fitted with an effective a silencer.

A driver may only compete in one car. Up to two drivers may share a car.

9. Awards will be presented as follows:

1st in each class with at least 4 starters - an award. 2nd in class with at least 8 starters - an award. Best Bristol Pegasus Member on class index - The Cross Trophy Cup plus an award.



No competitor may win more than one award. The Cross Trophy Cup is the property of, and will be retained by the Bristol Pegasus Motor Club.

10. The entry list opens on publication of these regulations and closes finally on 28th April 2024. The entry fee for the event is £15 in advance.

Online entry is preferred. If you cannot enter online you may use the paper form included in these regulations. The appropriate fee must be paid. Online entry is at https://bristolpegasus.com/events/cross-trophy-car-trial-2024/

- 12. The maximum entry for the meeting, including reserves, is 40. The minimum is 15. The maximum for each class is 20 and the minimum is 4. Should any of the above minimum figures not be reached, the organisers have the right to either cancel the meeting or amalgamate classes, as necessary. Entries will be selected at the discretion of the organisers. Entry fees may be refunded if the entry is withdrawn and notice given in writing to the secretary of the meeting, at least 24 hours before the event is due to start.

- 14. Provisional results will be published by e-mail within 7 days of the event.
- 15. Any protest must be lodged in accordance with C 5.1 to 5.7.
- 16. Competitors will be identified by numbers or score cards which will be provided by the organisers.
- 17. Marks will be awarded for completion of each section correctly as appropriate. Details of marking and penalties will be issued advised in the final instructions.
- 18. All other General Regulations of Motorsport UK apply as written.
- 19. For the Cross Trophy Performance on Index will be calculated in line with T7.3 and T7.4



- 20. Awards will be presented at the BPMC Annual General Meeting to be held on Monday 9th December 2024.
- 21. In line with Motor Sports Association policy, the Bristol Pegasus Motor Club has a responsibility to safeguard the wellbeing of young people working and competing in motor sport.
