Introduction

The event will consist of a number of special tests combining; skill and speed. Taking place on grass, in a single field, the event should appeal to anyone who would like a bit of fun in their car; any road car should be suitable.

Supplementary Regulations

1. The Bristol Pegasus Motor Club will organise a Clubsport status Gymkhana on Sunday 19th of June 2011 at Sheepcot Farm, Miss Graces Lane, Tidenham Chase Chepstow, NP16 7JR. Map Reference 172/549997.
2. The meeting will be governed by the General Regulations of the Motor Sports Association (Incorporating the provisions of the International Sporting code of the FIA), these Supplementary Regulations, and any written instructions that the organising club may issue for the event.
3. The following MSA Permits have been issued. Certificate of Exemption 64725
4. The Event is open to all fully elected members of the Bristol Pegasus Motor Club and all fully elected members of the following clubs:
MGCC (South West Region)
5. All entrants in the event must produce a valid membership card for either the promoting club or the invited club. No competition licence is required for this event.
6. The programme of the meeting will be as follows: Signing on and Scrutineering starts at 9-30. Any competitor not signed on by 9-45 may be EXCLUDED. The first car will start at 10-00.
7. Public roads will not be used to link sections. There will be at least 6 tests on private land. Each competitor will have at least two attempts at each test. Details of the tests will be explained at the start of each one. Passengers will be required. The entry may be split into groups starting on different sections.
8. The event will consist of a single class
Entries of vehicles with four wheel drive will be accepted. Commercial type vehicles may compete. Three wheel vehicles only accepted at organiser's discretion. All vehicles must comply with the MSA Technical Regulations, and must be fitted with an effective a silencer.
9. Awards will be presented as follows:
1st overall
2nd overall
3rd overall
No competitor may win more than one award.
10. The entry list opens on publication of these regulations and closes finally on 19th April 2011. The entry fee is £5 in advance or £6 on the day.
All entries must be made on the official entry form and accompanied by the appropriate fee. Cheques should be made payable to Bristol Pegasus Motor Club.

12. The maximum entry for the meeting, including reserves, is 40. The minimum is 5. Should the above minimum figure not be reached, the organisers have the right to cancel the meeting. Entries will be selected at the discretion of the organisers. Entry fees may be refunded if the entry is withdrawn and notice given in writing to the secretary of the meeting, at least 24 hours before the event is due to start.

14. Provisional results will be published by despatching a copy in writing by post within 7 days of the event.

15. Any protest must be lodged in accordance with C 5.1 to 5.7.

16. Competitors will be identified by numbers which will be provided by the organisers.

17. Marks will be awarded for completion of each section correctly as appropriate. Details of marking and penalties will be explained at start of each test.

18. All other General Regulations of the MSA apply as written.

19. Awards will be presented at the BPMC Annual General Meeting to be held on Monday 12th December 2011. If unable to attend the competitor is to make arrangements for award collection.

During the lunch break a BBQ should be available. Competitors and friends are encouraged to bring food and join the social part of the day.

Indemnification

I declare that:

 4. I understand that should I at any time of this event be suffering from any disability whether permanent or temporary which is likely to affect prejudicially my normal control of the vehicle, I may not take part unless I have declared such disability to the ASN which has, following such declaration, issued a licence which permits me to do so.
 5. Any application form for a Licence which was signed by a person under the age of 18 years was countersigned by that person's parent/legal guardian/guarantor, whose full names and addresses have been given.
 6. If I am the Parent/Guardian/Guarantor of the driver I understand that I shall have the right to be present during any procedure being carried out under the Supplementary Regulations issued for this event and the General Regulations of the MSA. As the Parent/Guardian/Guarantor I confirm that I have acquainted myself with the MSA General Regulations, agree to pay any appropriate charges and fees pursuant to those Regulations (to include any appendices thereto) and hereby agree to be bound by those Regulations and submit myself without reserve to the consequences resulting from those Regulations (and any subsequent alteration thereof). Further, I agree to pay as liquidated damages any fines imposed upon me up to the maxima set out in Part 3, Appendix 1.
